NOTES FOR THE GUIDANCE OF AUTHORS

**Submission:** Four complete copies of all scripts (two for Discussions) should be submitted by recorded delivery or registered post. You should also e-mail the abstract, which will be used by the editor for finding referees. Please send all scripts to Ms A. Hills, Geological Society Publishing House, Unit 7, Brassmill Enterprise Centre, Brassmill Lane, Bath BA1 3JN, UK (e-mail: angharad.hills@geolsoc.org.uk).

Authors should also submit titles and abstracts of any related papers that they have in press or in the review processes with other publications. These might be used during refereeing. Authors are invited to suggest three suitable referees (with e-mail addresses), but normally the editor uses a review by at least one referee not nominated by the author.

**Papers** on major topics of international interest in any of the Earth sciences are welcomed. Papers longer than 12 pages require special editorial approval. There are c. 1000 words on a printed page.

**Specials** of up to 4 printed pages on topical issues will be given priority for publication and be speeded through the reviewing and editing stages (see editorial, vol. 144, p. 367). The envelope should be clearly marked 'Special'.

Papers are accepted on the understanding that they have not been submitted or published elsewhere and become copyright of the Geological Society. Papers are also accepted on the understanding that all authors consent to the submission.

**Format:** Papers will be typeset from the author's disc. When your paper is accepted you will need to provide a Word or rich text format (.rtf) file.

Typescripts should be double-spaced, including references, on one side of the paper only with a 25 mm margin on each side. All pages should bear the author's name and be numbered serially. Text, figures and tables should be succinct, and photographs kept to a minimum. Papers should be arranged as follows.

Title: brief and specific; followed by name(s) and address(es) of authors (including e-mail address of corresponding author).

Abstract: this must be intelligible without reference to the paper, and should not exceed 200 words (100 for 'Specials').

Four or five keywords (to be chosen from the GeoRef Thesaurus).

Main body of paper: subdivided into 1st, 2nd and 3rd order headings; omit heading 'Introduction'.

Acknowledgements (if any).

Appendices: see Supplementary Publications below.

References: in full (see below).

Tables: each typed on a separate sheet (see below).

Captions for text-figures.

**References:** List all references cited. The author is responsible for ensuring that the references are correct. Reference in the text to papers with more than two authors should be made thus: (Smith *et al.* 1978), but cited in full in the References. Do not abbreviate journal titles. Please key the authors' names as Capitals and lower case. Use hyphens between page numbers and do not use commas in page numbers over 9999.

**Line drawings:** The top should be indicated. Drawings should have a line weight and lettering *suitable for reduction* to the type area of 236 × 176 mm or less. After reduction, the smallest capital lettering should not be less than 2 mm

high. A metric scale should be included, and north point (and where relevant, coordinates of latitude and longitude, or National Grid) put on all maps.

Use a recognized software package that allows you to save as EPS files with all fonts embedded and a tiff preview. Do not use default settings (e.g. minimum line or hairline) for line widths. These will not reproduce. If you produced the figures using CorelDraw, Illustrator or Freehand it would be helpful also to supply the native files.

*Hand-drawn diagrams* should be black on white card or opaque paper. Avoid fine stippling and tints. Do not scan these yourself.

**Photographs:** Ensure that the quality of the copies with the submitted manuscript is adequate for the referees to make their assessment. Do not mount photographs on a black background. If you wish to scan slides or photographs in order to annotate them, the resolution should be 300 dpi at the intended final size. TIF, GIF and PICT files are acceptable for halftone illustrations (but rarely adequate for line drawings).

**Colour and foldouts:** These will be accepted only after consultation with the Editor. Authors are normally expected to contribute towards the cost of production. Estimates of likely costs can be obtained from the Staff Editor. The above instructions apply. Please ensure that colour files to be printed are saved as CMYK, not RGB. It is possible to include colour version of a black and white printed figure in the online version at no cost if the same file can be used. If a modified file is required, a small charge will be made.

**Tables** will be typeset and should be designed to go across single or double column width of a *Journal* page. Please follow the style used in the *Journal*. Tables must be provided as Word, rich text format, Excel or comma delimited files.

**Offprints** may be ordered on the form provided at proof stage. Fifty free copies are supplied. You will also be sent instructions on how to obtain a PDF file

**Discussion of papers:** 1000-word discussions on papers that have already appeared in the *Journal* or appropriate Society books are acceptable. Two copies should be submitted with the title and authors(s) of the paper discussed.

**Supplementary Publications:** Limited space in the *Journal* means that detailed material, such as locality lists and analytical data, will be made available as Supplementary Publications. These files are stored in hard copy at the British Library and the Society Library and can now be hosted on the Society's website. Acceptable formats for the online repository are .rtf, .csv and .pdf. Maximum size is 5 MB per paper (can be zipped if necessary).
